Finding Careers in Government

On Tuesday, in Yvonne Theater, interested statesmen listened to an hour of discussion on what is available in government. The main topics discussed included civility, lobbying, and professions. Speakers Kay LaCausi and Matt McDermott Sr. spoke to statesmen on their careers and life stories. LaCausi started the conversation with mentions of civility and how the two were members of a bipartisan household with a liberal and a conservative. She pushed the belief that: "It is ok to disagree, but it is not ok to be disagreeable." That, she believed, is the poison in the well in modern discourse.

Further into the seminar, the two delved into their career paths, both entering their respective positions in the 90s. Both began with working at the State House in Trenton in various capacities and rose through the chain in offices. McDermott Sr. left the State House for positions in gubernatorial administrations. He worked for the Whitman and Christie administrations in many roles. Today, McDermott is the senior vice president of Kaufman Zita Group, with a job with Orsted. LaCausi left to start her own consultant firm, called Hoboken Strategy Group, Inc. There, she serves as president and helps clients like Honeywell.

As lobbyists they know the general distrust with the profession. Although they believe there are good and bad lobbyists, both speakers insisted they take more moral approaches. There were many, many questions, and in only an hour, the meeting ended a little over time.

The presentation mainly covered the actual logistics of law enforcement, and while I want to focus on the actual men behind this seminar, it can't hurt to touch on what the seminar was actually about. Becoming someone in this field of work is quite difficult, and a lot harder than many might expect. You not only have to be physically fit and intelligent, you must also have a fairly intense moral compass. That's probably the easiest part, but the actual application process is much harder. Firstly, an application must be sent in, similarly to a typical job. Then, an exam must be taken to test your knowledge, think of this like the written driving test. This then leads to several physical assessments, an interview, a more formal application (usually fifty pages of almost everything that has occurred in your life up until the point of applying), medical exams, a psychological test, and a background check. These can occur in any order, but the process as a whole barely changes. Officials will investigate your entire life, so be honest. The formal application is designed to test your integrity, so don't hide anything (you really don't want them to find out that you have ten speeding tickets when applying to be a police officer).

When the officers, veterans, investigators and more walked into the Gill Chapel, it was impossible to ignore the overwhelming sense of awe. These men are of immense honor, stature, and presence, and there is no doubt that they are amongst the most distinguished men in America and the world. They not only showcase discipline, respect, and honor, but they also put a large focus on following your dreams. Book Review: Dune

Known as a big inspiration for the Star Wars film series, Dune by Frank Herbert is one of the most popular science fiction novels ever written. It is around 400 pages long and is the first in a series of books. I haven't read any of the later books in the series as the first book has a conclusive, satisfying ending. In my opinion, the strongest aspect of this book is its plot. The story is filled with interesting politics, battles, and interactions between opposing sides. The Strife of Our Healthcare Workers

With the nearing end of the pandemic, many of us thought the battle in hospitals was over. However, it would appear that a new fight has risen from the end of COVID. Looking at Adams City, we see many front-line workers on strike over their unaffordable health care plan. The staff is upset that they are not paid enough to afford the high-quality healthcare plan offered by their hospital. Adams City is left without a running hospital and has begun to discuss either replacing the workers, meeting their demands, or simply closing the Saint Dominic Municipal Hospital. The growing problem in Adams has spread to its

neighboring city, Washington. The hospital has been served with multiple lawsuits due to its lack of efficiency from being understaffed. These lawsuits came after the violent graduation shooting and claimed that the victims could have survived if the hospital was more staffed. These problems have plagued the hospital and may lead Adams City to replace the workers or close the hospital altogether.

However, we must remember the work these strikers have done for the nation. They led the nation in the battle against COVID-19, working on the front lines and risking catching the virus. The fact that these people we call heroes can't receive the same treatment that they give us is outrageous. It is a moral and civic responsibility for Adams to maintain the hospital and provide the workers with better pay, along with expanding the funding of the medical institute. Though these workers are not on the same level as veterans, they deserve to be rewarded for their service to not only the country, but to the world.

College Vaccinations

Most U.S. colleges and universities already require on-campus students to show proof of vaccinations against illnesses like bacterial meningitis that can spread rapidly in close quarters. COVID-19 is a much more complicated story. Some attorneys say universities have the same right to mandate COVID-19 vaccines; however, the experimental vaccines are approved for emergency use only, putting the new mandates in a legal gray area.

Without approval from the FDA, Virginia Tech officials determined that they could not require COVID-19 vaccination. Harvard Law School professor Glenn Cohen counters that COVID-19 tests are approved under the same FDA emergency authorization and have been required by colleges all year without issue. Federal agencies, including the Department of Education and the Equal Employment Opportunity Commission, permit employers to require their employees get a COVID-19 vaccine.

A growing number of schools will require proof of a coronavirus vaccination for on-campus students this fall, including Cornell, Rutgers, and Oakland University in Michigan. Other schools are not requiring vaccines but will offer incentives, such as an exemption from the campus mask mandate. However, many more schools have yet to set a policy or have explicitly said they would not require proof.

The issue of requiring vaccinations is shaping up to be yet another political debate. A day after Nova Southeastern University in Florida announced it would require vaccinations, Governor Ron DeSantis, a Republican, issued an executive order banning businesses and government agencies from requiring vaccination documentation. All in all, vaccine mandates in higher education are typically set by the institutions themselves and could force students to have them based on where they attend.
